This limited warranty covers our product materials so long as there has not been contact with other materials stated to encourage corrosion as mentioned in this document (see "materials that may interfere with New Wave Gutter Guard").

Duration of The New Wave Gutter Guard 15 year limited warranty:

The New Wave Gutter Guard 15 year limited warranty is just that, 15 full years of coverage. Coverage begins once the materials have been installed and warranty registration has been completed and accepted. No pro-rating, No schedules!

What Products Innovation Group Inc will do once a claim has been submitted:

Products Innovation Group Inc will contact the original installation company for a formal inspection for any defects in materials or workmanship. If the original installation company is not available with a reasonable time, Products Innovation Group Inc will contact another local installation company at no additional cost to the customer. Once a warrantable problem has been identified, Products Innovation Group Inc will repair or replace the product at no additional cost to the customer. With normal weathering, the replacement product may be different in color or shine from the original. Products Innovation Group Inc reserves the right to change the design or color of any product without notice. If replacement of product is necessary, Products Innovation Group Inc reserves the right to replace with a comparable product should the original product no longer be available.

Circumstances where The New Wave Gutter Guard 15 year limited warranty would not apply:

- Routine maintenance not being performed
- Vandalism
- Alterations from original installation
- Damage caused by building or home structure settling or foundational distortion

- Accidental Damage

Proper care and maintenance:

New Wave Gutter Guard is the best performing aluminum gutter guard on the market. At times debris can build up on top of the New Wave Gutter Guard due to its non-clogging design and most debris will be removed naturally by wind gusts. If severe build-up of debris occurs, removal may be necessary for best results.

Materials that may interfere with New Wave Gutter Guard:

Corrosion can occur to the aluminum material used in New Wave Gutter Guard if it comes in contact with materials such as: copper, pressure treated lumber, zinc, steel, concrete, roofing materials that contain metallic, corrosive nonmetallic materials, stucco, asbestos, etc.

- Installation Company
- Date of warranty registration
- Name, address and phone number

Please submit your warranty claim to your installing dealer.

Transference of Warranty:

A transfer of warranty must be requested in writing no more than 60 days after any change in ownership has occurred. Please include the warranty registration number, name, address and phone number of original warranty owner, name, address and phone number of new owner.

There are no warranties on this product other than as set forth in this Warranty. We are not liable to you for a breach of any other written or oral express warranties, such as those, if any, given to you by dealers, contractors, applicators or distributors of the Product.
